Notice to Property Owners and Tenants:

*It is the property owner's responsibility
to ensure that sewer is paid.*

*If/when a tenant's account becomes delinquent,
a bill will be sent to the property owner for payment.*

Sewer rates are as follows, if paid by the due date on the coupon:

**Residential user rate \$60.00 per EDU,
Commercial user rate is \$65.00 per EDU,
Grinder Pump user rate \$50.00 per EDU,
...User Rates are subject to change at any time...**

**A 2% Discount is offered to customers opting to pay
the entire year, in full, by January 31, 2025, as follows:**

Residential customers may pay **\$705.60**.
(Instead of the full amount of \$720.00) which is a savings of \$14.40.

Commercial customers may pay **\$764.40**.
(Instead of the full amount of \$780.00) which is a savings of \$15.60.

Grinder Pump customers may pay **\$588.00**.
(Instead of the full amount of \$600.00) which is a savings of \$12.00.

**Homeowners with Grinder Pumps are responsible to pay for
new pumps and parts as parts for the older pumps are no longer available.**

Monthly Payments – Payments must be accompanied by the monthly coupon from the coupon booklet. All checks must have your account number on them. Payments may be mailed to GBMA, P. O. Box 276, Gratz, PA 17030. Payments may be placed in the drop off box located at the entrance to the Community Center Building at 125 North Center Street, Gratz. Payments are to be paid during the current month and must be postmarked or paid by the last day of the month. If paying after the last day of the month, please include a 10% late penalty with your payment.

Monthly Meetings - GBMA monthly meetings are held on the second Tuesday of every month at the Authority's office (the blue building located behind the Municipal Building) at 125 North Center Street. Meetings begin at 7:00 pm and are open to the public.

FLUSH WISELY! - Do not flush any type of grease, moistened wipes, paper towels, female hygiene products, prescription, or other medications. Please use environmentally friendly cleaning products. Products that color the toilet bowl water are not recommended. All the above items adversely affect the plant, causing extra expenditures to keep the plant in compliance with DEP guidelines; these costs must then be passed on to our customers.

Sump Pumps - The Authority has identified certain streets where flows increase during periods of rain. Door-to-door inspecting for violators will be conducted. Pending the results of these inspections, smoke testing may also be necessary. Customers will be notified before smoke testing is performed.

Rave – Gratz Borough and the Authority have a notification system in place to notify you in the event of a water/sewer issue or any other important event going on in the Borough. If you have not signed up, please do so. To sign up, write your phone number on your sewer coupon page to be added to the system. When we started the notification system, it was called Swift 911. That system has been sold to Rave, but the system will work the same. Your information will not be given to anyone else and will remain a part of the system set up for Gratz Borough.
